# Message from the Chair

I have a saying, 'keep on marching', and that's exactly what we've collectively done at the Victorian Pride Centre. Despite funding issues, latent site conditions and building delays, we have learned to adapt, as has our broader community, in a new COVID-19 world.

We have built support in the LGBTIQ community, including our second iteration of the Community Reference Group. We have negotiated agreements with potential tenants and our major funding partners, particularly, the Victorian Government. It was so pleasing to welcome Star Health, Transgender Victoria and the Monash Gender Clinic to the Pride Centre, in addition to those organisations that were originally slated to come to the Pride Centre – Thorne Harbour Health, JOY, Minus18, Australian Lesbian and Gay Archives, Switchboard Victoria Administration, Melbourne Queer Film Festival and Australian GLBTIQ Multicultural Council.

Our staffing structure is established for now, with our inaugural CEO, Justine Dalla Riva and her team – Miranda Coffey as Coordinator, Bree McKilligan as Pride Giving Advisor, Renee Thompson as Communications Coordinator and Jemma Bates as Project Manager. They have worked tirelessly to grow our funding supporter base, corporate sponsors and action a fundraising strategy. They have established our newsletter, developed virtual video tours and grown our social media presence and follower base. They have developed pricing policies for the future Pride Centre facilities, negotiated lease agreements and consulted with community to ensure everyone's voices are heard throughout.

Our team has established the Pride Centre Ambassadors – an illustrious group of proud Australian LGBTIQ Leaders – Benjamin Law, Julie McCrossin AM, Robyn Archer AO, Brook Andrew, Courtney Act, Danni Roche, Jason Ball, Nevo Zisin, Rhonda Galbally AC, Tony Ayres, Tony Briffa and Zoe Coombs Marr – and last but not least our Organisational Patron, the Hon Michael Kirby AC CMG.

This year has seen the Centre grow from bedrock up to a completed superstructure and progress on to the fit out of the building. Now that we're at the stage of fitting out the interior, I'd like to personally thank anyone who has purchased an item on the Pride Registry or contributed to a Giving Circle. We have a way to go, but your generosity during such uncertain times really shows the importance of the Pride Centre to the entire community.

On behalf of the board at the Victorian Pride Centre I would also like to acknowledge the support and work of James Morvell and his teams from Hall and Wilcox (our pro bono and low bono lawyers), Hansen and Yuncken (our builders), Case Meallin (project manager and site superintendent), Slattery (quantity surveyors) and our architects James Brearley and Grant Amon. These individuals and teams have helped us overcome some significant hurdles with hard rock and contaminated soil, COVID-19-related manufacturing and shipping delays, and slowdowns through the various COVID-19 restrictions.

I would like to pay tribute to the guidance of Ro Allen, our Commissioner for the LGBTIQ community, and to the significant support of Minister Martin Foley and the State treasurer, Tim Pallas. A special thanks to board, committees and the Community Reference Group.

I want to acknowledge my action-oriented board colleagues, all of whom have shouldered significant responsibilities this year – Peter McEwan, Chair, Property, Facilities and Programming Committee; Megan Smith, Chair, Communications Subcommittee and Co-Chair, Community Reference Group; Stuart Kollmorgen OAM, Chair, Fundraising Committee, Stephen Barrow-Yu, Chair, HR and Nominations Committee; Scott Hartley, Treasurer; Hang Vo, Chair, Program and Activation Working Group; and Kris Kornovich, Chair, Leasing Group.

I want to thank those many volunteers who have joined working groups, the Community Reference Group and committees. I will single out Amanda Kelly, Independent Chair, VPC Audit and Risk Committee and Steve Game for his chairing of the Founders Fund Team. I will take the opportunity to thank our outgoing board member, Georgie Harman, who along with Tass Mousaferiadis were Co-Chairs, Communications Subcommittee.

The next few months will see all of us move into 2021 and into a new phase for the Victorian Pride Centre as it takes its place on the national and the international stage. # 2019/20 Highlights

The Victorian Pride Centre has had a jam-packed year. Despite the challenges, this year has seen the Pride Centre emerge, from the ground up!

#### Here are the highlights:

June 2019 – Community lay cornerstone of Pride 50 years on from Stonewall

The Victorian Pride Centre literally cemented LGBTIQ pride in Australia by laying the cornerstone of Southeast Asia's first purpose built Pride Centre. The Minister for Equality, Martin Foley MP; Mayor of Port Phillip, Cr Dick Gross, and the Pride Centre Board

Chair, Jude Munro AO, poured and marked the first cornerstone of the building in the presence of dignitaries, supporters

of dignitaries, supporters and community members.
This signalled the start of major building works. On the 50th anniversary of the Stonewall riots, the laying of the cornerstone is another symbol of an end to decades of invisibility.

# August 2019 – Excavation begins, the Love crane soars

Excavation began on 8 August with the team working to create the cavity for basement level. The site tower 'Love' crane was installed at the end of August and was a significant milestone for the project. The name was chosen after reaching out to the community for suggestions to name the crane. Hansen Yuncken,

our building contractors, applied signage to the counterweights of the tower crane and a rainbow 'Love' was visible from most of Fitzroy Street.

# October 2019 – New Foundation Partner announced

We welcomed a new Foundation Partner – aged care provider **Lifeview**. The three-year

partnership with Lifeview will put a spotlight on the needs of older LGBTIQ Victorians. In addition to their financial contribution, Lifeview will provide educational resources related to aged care and run open days and bi-monthly events on ageing.





# 2019/20 Highlights

#### November 2019 - Minus 18 receive their keys

**Minus18**, Australia's LGBTIQ youth network, was the first organisation to sign a tenancy. Heads of Agreement at the Pride Centre. Jude Munro

AO, Board Chair, symbolically handed over the keys to what will be Minus18's new home when doors open. Minus18 will be located on Level 1 with a dedicated office space.

December 2019 – Welcoming more resident organisations

**JOY** The first dedicated LGBTIQ radio station in the world and Australia's only LGBTIQ radio station announced to relocate to the Pride Centre. Five purpose-built audio and video studios will support JOY in meeting both the challenges and opportunities of the digital age.

**StarHealth** announced as the Pride Centre's first commercial tenant. The leading provider of primary health and community care services in Melbourne's inner south-east agreed to take out the second floor of the Pride Centre for its administrative and organisational headquarters, along with outreach services.

**Switchboard**, Victoria's largest online and phone-based LGBTIQ counselling and referral service joined the growing list of Pride Centre resident organisations announcing their administrative and outreach services will relocate to the Pride Centre.

January 2020 –Thorne Harbour Health accept keys to the Pride Centre.

February 2020 – Minister announces an extra \$10M funding at Pride March

Onsite at the Pride Centre prior to the start of the 25th Midsumma Pride March, the Minister

for Equality, Martin Foley, announced an additional \$10 million contribution towards the construction of the Pride Centre. These additional funds will reduce the Pride

March 2020 – Melbourne Queer Film Festival and Transgender Victoria receive their keys to the Pride Centre

Australia's oldest and largest LGBTIQ film festival, Melbourne Queer Film Festival (MQFF), celebrating 30 years in 2020, announced they will be programming from the Pride Centre.

On Transgender **Day Of Visibility** (31 March) the
Victorian Pride Centre was
proud to announce Transgender

Victoria (TGV) as the next community organisation to set up an office at the centre. TGV has been a leading body for advocacy, support, education, and resource development in Victoria for more than 20 years.





# April 2020 - Australian Lesbian and Gay Archives announced as tenants and Pride Centre 'tops out'

Australian Lesbian and Gay Archives accepted their ceremonial key virtually during an online team meeting as the next LGBTIQ community organisation to sign a tenancy for the Pride Centre. Due to physical distancing the Victorian Pride Centre Chair Jude Munro AO made the announcement from home and remarked on the important and everchanging history of our community.

**Topping out** (image below) is a time-honoured construction tradition. It marks the structure reaching its highest point by placing a tree at the tallest point of a building to appease the tree-dwelling spirits displaced in its construction and bring good luck to its occupants.

A native acacia blackwood and coastal banksia indigenous to the Port Phillip area were hoisted onto the rooftop terrace. Coastal banksias form part of the Centre's garden design and will feature throughout the Centre.

#### May 2020 – Gandel Philanthropy supports 'Next Generation Pride'

On International Day Against Homophobia, Biophobia, Intersexism and Transphobia (17 May), the

Victorian Pride Centre announced that **Gandel Philanthropy**, one of several key philanthropic partners, generously provided a grant of \$130,000 for the Centre's Next Generation Pride. The initiative will see young people engaged to create welcoming, fun and safe spaces within the Pride Centre, brought to life with youth-driven programming in collaboration with **Minus18**.

# June 2020 – Organisational Patron and Ambassadors announced

We marked Pride Month by unveiling an esteemed list of LGBTIQ community Ambassadors, with Michael Kirby as the inaugural Organisational Patron.

The role of the Organisational Patron and Ambassadors is to raise the profile of the Victorian Pride Centre amongst the LGBTIQ community and the general population in Australia and internationally. The Pride Centre's twelve Ambassadors came on board representing the breadth of diversity within the community.

# **Building Update**

2019/20 has been a year of progress and challenges from a building front, but saw the Pride Centre come to life.

In July and August the excavation of 6000 cubic metres of soil and rock made way for the basement car park and the building's foundations. This became a turbulent time when the team struck large amounts of rock and asbestos, which were unable to be detected previously. Due to these unexpected hurdles, there was a delay to the program, but the project team worked tirelessly to ensure the best result was achieved. When this issue was resolved, over 120 concrete piles were poured and cemented, contributing to the formidable foundation that the Centre is built on.

By February 2020 the building structure started to appear above the street-front hoardings, which attracted a lot of interest from passers-by and sent a reassuring message to the community that we are here and that the building is steaming ahead. The first concrete pour was carried out in February, which was a significant milestone for the project. The mezzanine, Levels 1 and 2 soon followed. Between February and April, the team made impressive building progress, including pouring the rooftop slab and installing precast panels, which completed the external structure of the building. A 'topping out' ceremony took place to commemorate the significant milestone. All formwork scaffolding was removed from the basement, ground and mezzanine floors, which opened up the levels and allowed everyone to see the internal spaces taking shape.

Construction of the Pride Centre has continued under strict physical distancing measures. The continued construction during these uncertain times for the community and society as a whole has provided a sense of hope and a positive light at the end of the tunnel.

# Equitable Access -**Bookable Spaces**

In April 2020 the Board endorsed the Meeting Room and Event Space Booking Policy. To strike the balance between generating income (which is essential for our financial sustainability) and ensuring no community group is excluded, the policy has a three-tiered fee structure across commercial, large and small not-forprofit organisations. A fee waiver option is available for emerging and and/or struggling organisations. The policy provides principles upon which booking decisions can be managed transparently, consistently and equitably across a range of users, with preference given to bookings for LGBTIQ community purposes.

In June 2020 we finalised procurement of venue management software, which will provide a system for administering, tracking and reporting on meeting room and event space bookings. Resident organisations will be able to view real-time room availability and make instant bookings.

External users of the Pride Centre will have userfriendly web-based enquiry form to connect to Pride Centre staff for assistance in arranging hire of meeting rooms and/or event spaces.



# Staying Connected while Physically Distant

Late 2019 and 2020 presented new challenges in gathering and connecting with our community. With the devastating bushfires in late 2019 followed by 2020's ongoing COVID-19 pandemic, there was a real need to adapt by using new and existing technologies to stay connected. Having a solid foundation with our Virtual Pride Centre provided a good starting point for community to find resources and ways to connect during these times. The COVID-19 'new normal' being predominantly online revealed cohorts of the community who are significantly more isolated. In response to this we have enhanced our online presence, which will hopefully continue to assist in reaching isolated communities beyond the pandemic.

Using existing technology and social media platforms, we have adapted to this new digital environment and we recognise that making all of our content more accessible will be an ongoing effort.

# LGBTIQ Community Reference Group New Two-Year Term

Our Community Reference Group (CRG) provides an opportunity for a broad range of intersecting LGBTIQ perspectives and experiences to be considered during the build, establishment and operation of the Pride Centre.


Members identify as part of lesbian, gay, bisexual, trans and gender diverse, intersex or queer communities and/ or intersecting identities (Aboriginal and or Torres Strait Islander people, culturally and linguistically diverse people, young people, people living with a disability, rural or regional people, older people etc.) Members sit for a two-year term.

In March 2020, we undertook an expression of interest process for a new two-year term. We were pleased to have 18 inaugural members re-join the CRG and welcomed 15 new members, bringing the total membership to 33. The CRG has met four times over the course of the 2019/20 financial year, discussing topics such as programming and activation, governance and creating community in a COVID-19 world.

# Volunteer Program

Volunteers have been integral to the Pride Centre's development to date across a number of roles including sitting on Board subcommittees, volunteering at Pride Centre stalls during events and festivals and providing lived experience perspectives through the Community Reference Group.

When the Pride Centre is open, volunteers will continue to play a vital role in day-to-day operations. We are currently developing the on-site volunteer program and have already had over 100 expressions of interest to volunteer

A key volunteer role within the Pride Centre will be the 'concierge service' to direct people to the relevant floor for their meeting/service, answer questions about the Centre or just have a friendly chat.

There will be many other volunteer opportunities across administration, community engagement, programming and activation.

The on-site volunteer program will commence in the 2020/21 financial year.





## Community Fundraising

Despite the challenging times over the last year, the LGBTIQ community and allies have rallied to support the Pride Centre as it is being built. We have implemented a range of strategies to ensure the short and long-term sustainability of the Centre. This sustainability ensures that we can continue to offer our LGBTIQ resident organisations subsidised rental arrangements. Key activities and fundraising events included:

**Night of Pride**, City of Stonnington's Mayoral Charity Fundraiser Gala in October 2019 raised \$65,000 for the Pride Centre's theatre/multipurpose space. Guests enjoyed performances from the LGBTIQ community, and a spectacular range of auction items donated by leading Stonnington businesses.

Defiantly Proud to the End, an end of 2019 drinks event in support of our Wills and Bequests Program, was hosted by supporter Nicholas O'Donohue & Co. Commissioner Leigh Johns spoke of the proposed Religious Discrimination Bill and the threat it proposed for Australia's LGBTIQ community. The Wills and Bequests Program allows supporters to make a bequest to the Pride Centre in their will and leave a legacy for future generations.

When lockdown restrictions came into place our fundraising efforts and events had to quickly adapt to become predominantly online. Asking our community for money during a pandemic felt inappropriate, but saw creative solutions arise from the Fundraising Working Group. The online Pride Registry platform was born out of a need to offer something more tangible for donors and supporters than asking for monetary donations.

The Pride Registry, inspired by the concept of a bridal registry, allows supporters to 'shop' for items to fit out the Pride Centre, fulfilling their satisfaction by contributing directly to a physical shared community space. The Pride Registry includes items for supporters to purchase as small as an indoor plant or as large

as a roof top pavilion; this way there's a piece of pride available to purchase that suits all budgets. Giving Circles, where friends or colleagues come together to fundraise, can be set up for larger items. Donors of items of \$9000 or more will be recognised on a plaque, on or near the items.

We also transitioned to **Virtual Site Tours** for philanthropic supporters and community members, with our Chair, Jude Munro AO, and Fundraising Chair, Stuart Kollmorgen, in high-vis giving tours of the building site. The tours also featured keynote speakers, including our inaugural Organisational Patron Michael Kirby, giving people nationally insight into this exciting initiative.

Another recent challenge that was met with grace was funding our flagpole. What is a Pride Centre without a Pride flag? A generous group of community members urgently fundraised in honour of lost loved ones so the Centre could fly a Pride flag as a beacon of hope for all who would see it.

# Opportunities for our Community to Support Us

In addition to the Pride Registry, there are numerous other ways our community can support the Pride Centre.

Naming Rights, the sponsoring of physical spaces within the Pride Centre for three, ten or seventeen years, are available for both community supporters and corporate sponsors. Again, Giving Circles can enable community members to band together and increase their impact and support.

We are hoping to see spaces named after well-loved LGBTIQ people and important LGBTIQ places and milestones.

Community members can show their support with a yearly donation as **Cornerstone Supporters** (\$100) and/or **Pride Club** (\$50/\$20). Supporters are kept up to date with the monthly Rainbow Road news updates and will be profiled on our social media platforms.

Our **Patron Program** enables patrons to donate for a minimum of three years at one of four levels – Bronze, Silver, Gold and Platinum – which range from \$2,000 to \$10,000 a year. Patrons gain access to special events at the Pride Centre and are celebrated in our ground floor honour board, along with all donors of \$5,000 or over.

# We are a Registered Charity with Deductible Gift Recipient 1 Status.

Our investment scheme, the **Founders Fund**, is an opportunity for community members to invest in the bricks and mortar of the building, with investors seeing a return in 2037. Our Founders Finishing Line Campaign to achieve a target of \$1 million by the time the Fund closes to new investors on the 21st December 2020 has been successful to date.

# Philanthropic & Corporate Support

The Pride Centre is attracting the support of philanthropic organisations. Joining the Broadtree Foundation as a Major Supporter, the Sidney Myer Fund contributed \$50,000 toward the fit-out of the Level 1 co-working space and Gandel Philanthropy donated \$130,000 over three years to Next Generation Pride.

Key corporate organisations came on board for threeyear corporate partnerships that will sustain the yearly operations of the Pride Centre. They include IBM (Founding Principal Partner), Lifeview and House of Wellness (both Major Partner + Foundation Partner) and the National Bank of Australia (Foundation Partner). Bank Australia continues to support the Centre as our Social Impact Lender and many other organisations provided valuable in-kind support including Hall & Wilcox and Cushman and Wakefield.

The Pride Centre is excited about our partnerships and looks to co-partnering on a range of initiatives with them to benefit the LGBTIQ community.

We thank all of the fabulous and hard-working people who've engaged in fundraising for the Pride Centre in 2019/20.

# **FINANCIALS**

The financial performance of the Victorian Pride Centre for the year ended 30 June 2020 is reflective of the stage of the Centre's development, i.e. Mid-Construction.


The financial year saw an increase in the value of the constructed asset of \$20.3 million to \$37.9 million. This was predominantly funded through State Government Grants in addition to borrowings from Bank Australia.

Whilst as illustrated below, the majority of our revenue was sourced from State Government Grants, we are still reliant, and most grateful for Donations, Corporate Sponsorships and Pro Bono services which have helped in establishing and promoting what is hoped to be the "most loved, well known and visited home for the LGBTIQ community in Australia".

The coming financial year will see the completion of the construction of the Victorian Pride Centre, the cost of which will largely be funded through borrowings from the Treasury Corporation of Victoria. Once opened we anticipate our revenue mix to substantially change to a more balanced mix of tenancy revenue, corporate sponsorships, fundraising and donations.
